5. The IISU shall extend referral and linkage support to TEIIC with other incubators and ecosystem enablers.
6. The IISU shall facilitate to the TEIIC, access to collaboration and Business/ Market Linkage and access to the knowledge resource- e library and library at the institute.
7. The IPR Cell of the IISU shall facilitate TEIIC in protecting innovation and intellectual property. The intellectual property services shall include Prior-art search report, patentability opinion, drafting patent specification, preparing filing documents, filing application and follow-up, prosecuting the filed application by responding office action such as FER etc, advisory services on various IPR, IP management, reviewing IP policy of the TEIIC, organizing various capacity building workshops/conferences on IPR etc.
8. IISU will help in the outreach of the joint programs through its channels like email, social media handles.
9. Publicize TEIIC within its ecosystem.
