At this important juncture where you decide the future course of action for yourself, we are there to guide and help you to make this process smooth.

Please note a few important points w.r.t Provisional Admission to grade XI- 2025-26:

- Counseling Session: At 09:00 a.m. on 20<sup>th</sup> March 2025, Venue IIS Auditorium.
   Students must attend the same (in school uniform). Parents are also invited.
- The E-Option cum Subject Combination form will be available on the school website www.icfia.org, 20<sup>th</sup> March, 2025 onwards.
   (Click on the button available on the homepage of the school website for the same)
- The list of eligible students for various streams will be uploaded on the school website on 20<sup>th</sup> March 2025 at 03:00 p.m.
- Accordingly, students are advised to fill up the E-Option cum Subject Combination form, online. However, if any student wishes to opt for a subject combination for which he or she is not eligible, the student along with the parents should visit the school on 21<sup>st</sup> & 22<sup>nd</sup> March, 2025 between 11:00 a.m. and 01:00 p.m. to meet the School Coordinator for grade XI regarding the same.
- Also note that, the CBSE does not permit any change of stream/subject once class XI registrations are done by the school.
   Please be very judicious in making this choice.
- The last date for the submission of the E-Option cum Subject Combination form is 24th March, 2025.
- Parents may visit the book store to buy the copies/register sand the uniform on 28<sup>th</sup> and 29<sup>th</sup> March 2025.
- Also note the school's special provision of a 25% waiver on tuition fee for class XI students scoring 95% and above in their class 10 board exams. A 10% fee waiver in tuition fee of class XI will be given to those who score 90% to less than 95% marks in class X Board Exams.

As the Board Result will be declared in the month of May 2025, 1st installment fee waiver will be included in the 2nd installment for the deserving students.

 The due date for online fee payment of grade XI 2025-26 (first installment) via the school app is 31st March 2025 with a grace period upto 7th April 2025, after which penalty will be imposed as per the Revised Fee Policy already shared by the school on 8<sup>th</sup> March 2025.

The academic session 2025-26 for grade XI will commence on 3rd April, 2025.



- For a smooth transition from grade X to XI, it is important for students to make the right choice of subjects in grade XI
- Your grade XI choice of stream/subjects significantly shapes your career path.
- Subjects of real interest make you feel confident.
- Do NOT get carried away by peer pressure or any other external influence
- A wrong choice of subjects in grade XI will lead to 2 stressful years as CBSE has announced it last year vide Circular No. Ce/CBSE/COORD/2024 dated 19<sup>th</sup> September 2024, that No CHANGE OF SUBJECTS will be permitted after CBSE Registration of Students in grade XI. Subjects registered in grade XI cannot changed by students in grade XII. Request if any will be considered for the Supplementary Exam-XII only.

You may be aware that CBSE has started the Registration of Students for Class IX/XI and submission of the List of Candidates (LOC) for the students of Class X/XII. For the parents whose wards are studying in Class IX & XI or Class X & XII, submission of correct personal details and subjects offered are of utmost importance for the future of your ward and the smooth conduct of examinations. Prioritizing attention at this moment will save your ward from many serious consequences pertaining to passing documents with correct details and correct subjects to ensure the availability of correct subject question papers in the examinations.

It has been observed that during Registration and submission of LOC, parents are submitting incorrect information and once the Registration and LOC process is over and even after the result is declared, they are making requests to the schools and Board to correct the data of the students. Also, the request is made to correct the subject(s) after the submission of the LOC which affects the smooth conduct of examination.

The Board has taken the following decisions to ensure the smooth conduct of examinations and to avoid problems for the examinee:

 Once the date of Registration and submission of LOC is over, no request to change/correct personal data will be allowed. Page-2

2. In Classes X & XII, no subject correction will be made once the LOC submission is over for the main examinations. Request if any will be considered for supplementary examinations only. Such students may decide to appear or not to appear in the Main examination in the subject(s) which they have submitted in the LOC. However, their results will be declared as per the Examination Byclaws of the Board.

To avoid the above problems, the following requests are made to the parents:

- 1. Be attentive when agreeing to the information for registration and LOC.
- The personal data of your ward i.e. Name, Date of Birth, Mother's Name and Father's name should be correctly filled in for registration and LOC.
- All names with the expanded form may be filled in and not the short names as in future at many places, documents in extended form are required.
- The surname must be given in case your ward is planning to go abroad as this is the requirement of several countries.
- 5. The Date of Birth should be correct in all respects.
- While submitting data, details given in the passport may also be checked, if a passport has been issued to your ward.
- Subjects be filled in with due care in the LOC of both Classes X and XII as no change will be accepted after LOC submission for the main examinations.
- 8. It is the responsibility of the parents that all data submitted should be correct.
- The parents are also requested to visit the schools and support them in the timely submission of the Registration and LOC as once the date is over, no date will be extended.

With this letter, CBSE is approaching the parents to bring it to their notice that correct data submission is the first requirement for the successful conduct of examinations. Your valuable time and attention given for correct data and subject submission will not only help the Board in smooth and fair conduct of examination but save the parents & students also from several problems which they might face in future because of the wrong submission of data and subjects.


